## Defeating Daesh Highlights of the Week

**SOUTHWEST ASIA** – Our partners in Iraq and Syria are leading the way to find and eliminate Daesh fighters and their finance, logistics, and media networks.

“Temperatures as high as 52° Celsius did not stop our security forces partners in Iraq and Syria from searching for ISIS terrorists,” said Col. Myles B. Caggins III, Coalition military spokesman. “Since 2014, together, we have been strong and successful against Daesh.”

**During the week of August 12 - 18, 2020, the following actions happened in Iraq:**

- August 12: Within the framework of combating terrorism and eliminating sleeper cells activities, a joint force from Military Intelligence Detachments and the Intelligence, Reconnaissance and Surveillance Regiment, 16th Division, Ninawa Operations Command, captured four leaders of Daesh sleeper cells wanted by the Iraqi Judiciary in Mosul city.

- August 12: Based on intelligence, Military Intelligence Detachments from the 16th Division, in coordination with the 3rd Regiment, 75th Infantry Brigade, Ninawa Operations Command, located a Daesh tunnel containing a number of explosive devices and rockets in Hammam al-Alil district, Mosul. The tunnel had been used by the terrorists as a launching pad to attack civilians and security forces. The tunnel and the captured materials were subsequently destroyed by the Field Engineering Detachment.

remaining Daesh groups from melting into the desert region and using it as a base for future attacks, Anbar Operations Command launched a search and clearance operation in the sprawling desert north the international highway towards the administrative border with Jazeera Operations Command. As a result of the operation: a number of explosive devices, mortar rounds and explosives were located north the international highway, mortar rounds and rocket launchers were found in al-Za'atana area, Fallujah district. The captured materials were subsequently destroyed in a controlled explosion. Meanwhile, a terrorist wanted by the Iraqi Judiciary was captured in al-Halabsa checkpoint. The captured terrorist was handed over to the appropriate authority.

- August 13: Field Detachments from Wasit Intelligence and Security Directorate, in cooperation with joint security detachments, located a cache of ammunition in al-Suwayrah district, Wasit province. The seized cache was removed from the site by the Field Engineering Detachment according to Explosives Safety Standards.

- August 13: Jazeera Operations Command launched a clearance operation south of the Euphrates River and al-Shamiyah desert towards the administrative borders with Anbar Operations Command. Five Daesh safe houses containing rifles, ammunition, magazines, a motorcycle rigged with explosives, food, and mattresses were located and subsequently destroyed.

- August 13: A joint force from Military Intelligence Detachments, the 16th Division, Ninawa Operations Command and the 92nd Infantry Brigade, 15th Division located a cache of ammunition and explosive belts in Badush mountain range, Mosul. - August 14: Detachments from Diyala Intelligence Agency, Iraqi Ministry of Interior (MoI) alongside Diyala Police raided a Daesh hideout in Kharr al-Wahsh area, Khanaqin district and captured a terrorist wanted by the . The captured terrorist had reportedly been involved in transporting other fighters who would later be used in suicide attacks. The hideout was subsequently destroyed. The operation aimed to detect, disrupt and dismantle terrorist networks, and deny their ability to mobilize and travel through rugged terrain areas.

- August 16: After security monitoring and follow-up, the heroes of Iraqi Counter-Terrorism Service captured five hardcore terrorists wanted by the Iraqi Judiciary during separate raids in Ninawa and Salah Ad-Din provinces. One of the terrorists was involved in the Camp Speicher massacre in 2014, accompanied by two other terrorists were captured in Salah Ad-Din province. Two additional terrorists were captured in Mosul and Salah Ad-Din during separate raids.

- August 16: In a continuation of efforts by Iraqi Security Forces to clear cities of mines and other explosive remnants of war, Anbar Operations Command launched extensive search and clearance operations. As a result of the operations: 34 rockets, anti-aircraft systems, and illumination bombs were located in al-Wafa district, Abu Al-Jir, al-Ramadi district. A number of mortar rounds, homemade explosive devices and a rocket projectile were located in al-Lahib area, al-Karma district. All the seized materials were subsequently destroyed in a controlled explosion. Additionally, two terrorists wanted by the Iraqi Judiciary were captured in al-Jolan neighborhood, Fallujah district and subsequently handed over to the appropriate authorities.

- August 17: Troops from Samarra Operations Command, conducted a search and clearance operation on West Samarra Island. Three explosive devices, remnants from Daesh, were located and subsequently destroyed in a controlled explosion. Additionally, Samarra Intelligence and Counter-Terrorism Directorate, in coordination with the Headquarters' Intelligence and Security Department captured two terrorists wanted by the Iraqi Judiciary.

Paratroopers from Anbar Operations Command destroyed a Daesh safe house within the area of responsibility. A terrorist wanted by the Iraqi Judiciary was captured at al-Halabsah checkpoint and subsequently was handed over to Fallujah Police Department. Meanwhile, a force from the 38th Infantry Brigade, 10th Division alongside Field Engineering Battalion and the HALO Trust Company for mine removal, destroyed 41 explosive devices, remnants from Daesh, near the Olympic Stadium.
